## Emergency Overview

**Physical Description & Colour:** White crystalline solid - presented as a small ball.

**Odour:** Characteristic aromatic odour.

**Major Health Hazards:** Contact with naphthalene can cause skin photosensitivity on contacted areas. Subsequent exposure to UV alpha rays in sunlight can cause sunburn in affected area. Limited evidence of a carcinogenic effect, harmful if swallowed.

## Section 3 - Composition/Information on Ingredients

This is a commercial product whose exact ratio of components may vary slightly. Minor quantities of other non hazardous ingredients are also possible.

The SWA TWA exposure value is the average airborne concentration of a particular substance when calculated over a normal 8 hour working day for a 5 day working week. The STEL (Short Term Exposure Limit) is an exposure value that may be equalled (but should not be exceeded) for no longer than 15 minutes and should not be repeated more than 4 times per day. There should be at least 60 minutes between successive exposures at the STEL. The term "peak" is used when the TWA limit, because of the rapid action of the substance, should never be exceeded, even briefly.

## Section 4 - First Aid Measures

### General Information:

You should call The Poisons Information Centre if you feel that you may have been poisoned, burned or irritated by this product. The number is 13 1126 from anywhere in Australia (0800 764 766 in New Zealand) and is available at all times. Have this SDS with you when you call.

**Inhalation:** First aid is not generally required. If in doubt, contact a Poisons Information Centre or a doctor.

**Skin Contact:** Wash gently and thoroughly with water (use non-abrasive soap if necessary) for 5 minutes or until chemical is removed. After drying, apply a broad spectrum UV blockout cream. Keep out of direct sunlight for the next 2-3 days to avoid sunburn to potentially photosensitised skin areas.

**Eye Contact:** Quickly and gently brush particles from eyes. No effects expected. If irritation does occur, flush contaminated eye(s) with lukewarm, gently flowing water for 5 minutes or until the product is removed. Obtain medical advice if irritation becomes painful or lasts more than a few minutes. Take special care if exposed person is wearing contact lenses.

**Ingestion:** If swallowed, do NOT induce vomiting. Wash mouth with water and contact a Poisons Information Centre, or call a doctor.

## Section 5 - Fire Fighting Measures

**Fire and Explosion Hazards:** The major hazard in fires is usually inhalation of heated and toxic or oxygen deficient (or both), fire gases. There is little risk of an explosion from this product if commercial quantities are involved in a fire. This product will probably cause the fire to intensify as contents ignite. Violent steam generation or eruption may occur upon application of direct water stream on hot liquids. This product, if scattered, may form flammable or explosive dust clouds in air.

Fire decomposition products from this product may be toxic if inhaled. Take appropriate protective measures.

**Extinguishing Media:** Coarse water spray is the preferred medium for large fires. Try to contain spills, minimise spillage entering drains or water courses.

**Fire Fighting:** If a significant quantity of this product is involved in a fire, call the fire brigade. There is little danger of a violent reaction or explosion if significant quantities of this product are involved in a fire. Recommended personal protective equipment is full fire kit and breathing apparatus.

## Section 6 - Accidental Release Measures

**Accidental release:** This product is sold in small packages, and the accidental release from one of these is not usually a cause for concern. For minor spills, clean up, rinsing to sewer and put empty container in garbage. Although no special protective clothing is normally necessary because of occasional minor contact with this product, it is good practice to wear impermeable gloves when handling chemical products. In the event of a major spill, prevent spillage from entering drains or water courses and call emergency services.

## Section 7 - Handling and Storage

**Handling:** Keep exposure to this product to a minimum, and minimise the quantities kept in work areas. Check Section 8 of this SDS for details of personal protective measures, and make sure that those measures are followed. The measures detailed below under "Storage" should be followed during handling in order to minimise risks to persons using the product in the workplace. Also, avoid contact or contamination of product with incompatible materials listed in Section 10.

**Storage:** This product is a Scheduled Poison. Observe all relevant regulations regarding sale, transport and storage of this schedule of poison. Store in a cool, well ventilated area, and make sure that surrounding electrical devices and switches are suitable. Check containers periodically for leaks. Containers should be kept closed in order to minimise contamination. Make sure that the product does not come into contact with substances listed under "Incompatibilities" in Section 10. If you keep more than 10000kg or L of Dangerous Goods of Packaging Group III, you may be required to license the premises or notify your Dangerous Goods authority. If you have any doubts, we suggest you contact your Dangerous Goods authority in order to clarify your obligations. Check packaging - there may be further storage instructions on the label.

No special equipment is usually needed when occasionally handling small quantities. The following instructions are for bulk handling or where regular exposure in an occupational setting occurs without proper containment systems.

**Ventilation:** This product should only be used in a well ventilated area. If natural ventilation is inadequate, use of a fan is suggested.

**Eye Protection:** Eye protection is not normally necessary when this product is being used. However, if in doubt, wear suitable protective glasses or goggles.

**Skin Protection:** You should avoid contact even with mild skin irritants. Therefore you should wear suitable impervious elbow-length gloves and facial protection when handling this product. See below for suitable material types.

**Protective Material Types:** We suggest that protective clothing be made from the following materials: rubber, PVC.

## Section 10 - Stability and Reactivity

**Reactivity:** This product is unlikely to react or decompose under normal storage conditions. However, if you have any doubts, contact the supplier for advice on shelf life properties.

**Conditions to Avoid:** This product should be kept in a cool place, preferably below 30°C. Keep containers tightly closed. Containers should be kept dry. Keep containers and surrounding areas well ventilated. Keep away from heat, flames and sparks.

**Incompatibilities:** water, oxidising agents.

**Fire Decomposition:** Combustion forms carbon dioxide, and if incomplete, carbon monoxide and possibly smoke. Water is also formed. Carbon monoxide poisoning produces headache, weakness, nausea, dizziness, confusion, dimness of vision, disturbance of judgment, and unconsciousness followed by coma and death.

**Polymerisation:** Polymerisation reactions are unlikely; they are not expected to occur.

## Section 11 - Toxicological Information

**Toxicity:** Naphthalene did not cause birth defects when administered orally to rabbits, rats and mice during pregnancy, but slightly reduced litter size in mice at dose levels that were lethal to the pregnant females. Naphthalene has been reported to cross the human placenta.

**Genetic toxicology.** Naphthalene cause chromosome aberrations in Chinese hamster ovary cells but was not a mutagen in several other in-vitro tests.

**Carcinogenicity:** In a study conducted by the National Toxicology program (NTP), mice exposed to 10-30ppm naphthalene by inhalation for two years had increased incidences of metaplasia in the nose and the lungs as well as chronic inflammation of both the nose and lungs. The incidence of benign lung tumours (alveolar/bronchiolar adenomas) was significantly increased in the high dose female group but not in the male groups. The significance of this study to humans has not been established. No carcinogenic effect was reported in a 2-year feeding study in rats receiving naphthalene at 41mg/kg/day. Exposure to naphthalene has been reported to caused methaemoglobinemia and/or haemolytic anaemia, especially in humans deficient in the enzyme glucose-6-phosphate dehydrogenase. Laboratory animals given repeated oral doses of naphthalene have developed cataracts. There is no data to hand indicating any particular target organs.

## Potential Health Effects

### Inhalation:

**Short Term Exposure:** Available data indicates that this product is not harmful. However product may be mildly irritating, although unlikely to cause anything more than mild transient discomfort.

**Long Term Exposure:** No data for health effects associated with long term inhalation.

### Skin Contact:

**Short Term Exposure:** Available data indicates that this product is not harmful. It should present no hazards in normal use. However product may be irritating, but is unlikely to cause anything more than mild transient discomfort. Contact with naphthalene can cause skin photosensitivity on contacted areas. Subsequent exposure to UV alpha rays in sunlight can cause sunburn in affected area.

**Long Term Exposure:** No data for health effects associated with long term skin exposure.

### Eye Contact:

**Short Term Exposure:** This product may be mildly irritating to eyes, but is unlikely to cause anything more than mild discomfort which should disappear once product is removed.

**Long Term Exposure:** No data for health effects associated with long term eye exposure.

### Ingestion:

**Short Term Exposure:** Significant oral exposure is considered to be unlikely. Available data shows that this product is harmful, but symptoms are not available. However, this product may be irritating to mucous membranes but is unlikely to cause anything more than transient discomfort.

**Long Term Exposure:** No data for health effects associated with long term ingestion.

### Carcinogen Status:

**SWA:** No significant ingredient is classified as carcinogenic by SWA.

**NTP:** Naphthalene is classified by NTP as reasonably anticipated to be carcinogenic to humans. See the NTP website for further details. A web address has not been provided as addresses frequently change.

**IARC:** Naphthalene is classed 2b IARC - possibly carcinogenic to humans. See the IARC website for further details. A web address has not been provided as addresses frequently change.

## Section 12 - Ecological Information

Very toxic to aquatic organisms, may cause long-term adverse effects to the aquatic environment.

**SOIL:** Naphthalene is adsorbed moderately to soil and undergoes biodegradation.

**WATER:** When released into water, naphthalene will evaporate into the atmosphere with a half-life of a couple of days to a few months. Biodegradation is also common from water and bioconcentration occurs to a moderate extent.

**ATMOSPHERE:** When released into the atmosphere, naphthalene rapidly photodegrades (half-life 3-8 hours). No environmental data available for Naphthalene.

## Section 13 - Disposal Considerations

**Disposal:** Dispose of small quantities and empty containers by wrapping with paper and putting in garbage. For larger quantities, if recycling or reclaiming is not possible, use a commercial waste disposal service.
